Raw materials for production are also sourced locally as well as internationally from countries such as China, Hong Kong, Taiwan and India and all raw materials are sourced from OEKO-TEX certified factories.

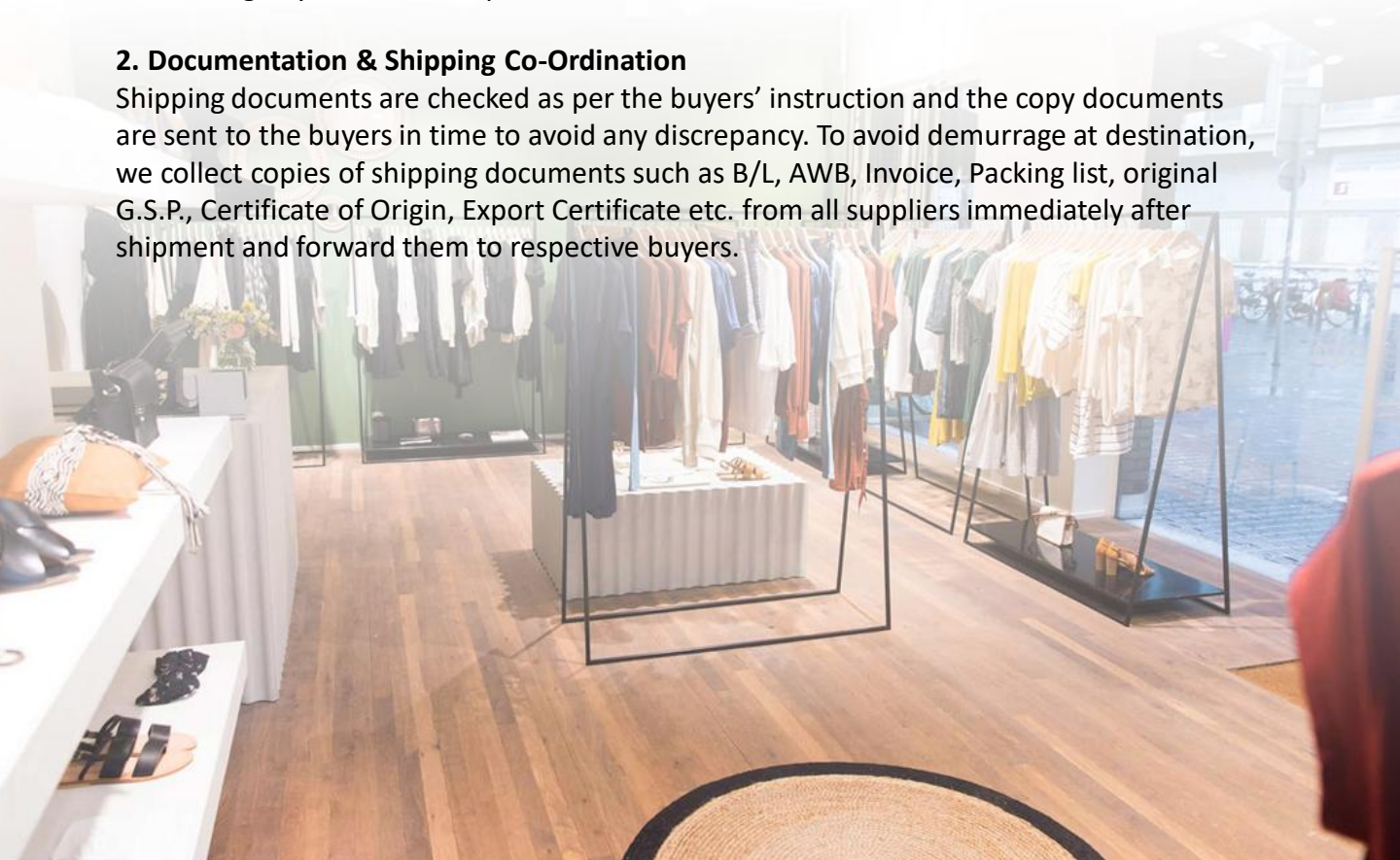
1. Container Stuffing & Loading Supervision

An identification of the goods during the loading is made to ensure that only the inspected goods are being stuffed without getting mixed up with the un-inspected goods. Shipping documents are checked to verify their conformity to buyer's instructions and sent in advance to the buyer.

As a policy, we insist that all our cargo must be handled only by a reputed Forwarder, so that, we get correct information well in time about exact sailing details, ETD / ETA of vessels. We also try for priority in booking and loading wherever possible. In suitable circumstances, we may arrange grouping of cargo arriving from different suppliers. This system enables the buyer to import several consignments as one lot and reduces his import cost on freight, clearing, forwarding and cargo handling. We can assist if required in negotiating and obtain special freight rates on the basis of regular turnover. This too results in reducing buyer's cost of import.

2. Documentation & Shipping Co-Ordination

Shipping documents are checked as per the buyers' instruction and the copy documents are sent to the buyers in time to avoid any discrepancy. To avoid demurrage at destination, we collect copies of shipping documents such as B/L, AWB, Invoice, Packing list, original G.S.P., Certificate of Origin, Export Certificate etc. from all suppliers immediately after shipment and forward them to respective buyers.

Pricing: For fixation of price, the detail enquiry is required to be provided by buyer. Based on which, we will quote our rate which will be valid for bulk order confirmation. Price can vary without prior notice if the order quantity is different than the enquired quantity.

For air or sea freight calculation, please refer to the packing statistics.

Samples: For regular clients, who already sent us purchase orders, all samples up to 5 PCS are free. For clients, who need more than 5 PCS of sales sample but has not sent purchase orders to us, all cost of samples will be borne by them.

Ordering: Written purchase orders (by fax or email) are required before action is taken on any order. Prices and availability are subject to change without notice. So please confirm the prices with us before you send us purchase orders.

We shall fax or email you about Sales Confirmation for your signature within 3 working days, after receiving your order.

Business hours: Saturday - Thursday. 9:00 AM to 6:00 PM BST (+6 GMT)

Delivery Time: Our production department only arranges all order in strict rotation from the time of receiving L/C. As quicker you organize payments, sooner the delivery time will be.

If your order does not require any logo, screen printing or embroidery, it is more convenient for us but if your order requires logo, screen printing or embroidery, please manage to do color scan your art works (logo) and send it to us by email. The preferred formats are .jpg and .pdf.

Please respond or forward your customers comments to us as soon as you receive our counter samples. This can allow us time to make necessary alterations/corrections, if any.

Our normal delivery time is 70-80 days (with Local fabrics), after L/C received.

For Imported fabrics the delivery time is 110-120 days, after L/C received.

Packing: We follow standard packing instructions of the buyers.

Terms of Payments: For orders valued less than 10,000 US\$, we suggest you to pay 50% in advance by wire transfer and the balance 50% by wire transfer five days before the shipment. For orders valued at more than 10,000 US\$. You need to establish an irrevocable L/C at site.
